Enclosed is a copy of Act 2014-409 which was approved and signed by Governor Robert Bentley on April 9, 2014, which extends the City of Foley's corporate boundaries to include portions of US Hwy. 98 West. The City of Foley welcomes you and your neighbors to the City. The official date for City services will be Tuesday, July 1, 2014.

The City provides its residents a number of services and any of your residents can contact the City of Foley at 943-1545 to address any questions that they may have. However, I wanted to specifically identify a few services that you and your neighbors should be aware of that will begin July 1st.

- The City of Foley Police Department will begin answering any calls starting on July 1st, and routine patrols in and around your neighborhood will be initiated. They will also begin handling animal control services on this same date. Our Police Department actively supports our residents, including helping to set up Neighborhood Watch programs, and providing services such as the House Check program for residents away on vacation, etc. For more information on the various services and programs offered by the Police Department please call 943-4431.
- The City Sanitation Department's hours are from 6:00 a.m. until 2:00 p.m. Your trash collection days will be Wednesday for household garbage, yard debris, and recycling. Garbage and recycle containers must be out at the curb by 6:00 a.m. the day of pickup. Residents who have bulky waste will need to call 943-8897 to schedule these pickups. Mosquito spraying is once a week weather permitting.
- In order to set up your trash collection service please contact Riviera Utilities. They can be reached at 943-5001. Rather than receiving a separate bill as you currently do from the County, you will benefit from a consolidated bill as the City contracts with the power company for billing. Therefore you will see a sanitation charge on future water bills (Riviera Utilities), rather than a separate bill.
