Crisis Team Coordinator Eric Morris reported Foley Police Department is requesting to authorize the Mayor to sign a contract for mental health services with AltaPointe Health Systems (AHS). Officers respond to numerous calls for service involving individuals having a behavioral crisis that may or may not be of a criminal nature. These encounters often times require the officer to solely rely upon his/her training in de-escalation to calm the situation of which they are in. AltaPointe Health Systems has offered a service to the Foley Police Department using technology by way of an IPAD and a connection to MyCare software for officers to connect virtually with real-time mental health professionals who can provide guidance, assessments and recommendations during these encounters, as requested by the officers. In addition, this same software can be utilized by our department employees providing confidential support to our own employees in their time of need. Foley Police Department will reimburse AHS \$85.00/month for the services listed in the attached MOU. The agreement will begin on Sept 1, 2025 and end on August 31, 2027. This agreement may be terminated by either party at anytime throughout the contract by issuing a 30 day notice in writing. The IPAD will remain the property of AHS after termination.

Fire Chief Joey Darby reported the Fire Department is requesting to purchase hydraulic rescue tools to be used for extrication of victims in motor vehicle accidents, structural collapse, and other incidents with entrapment. This purchase will add a modern set of tools to our new ladder truck that is scheduled for delivery next year. This set will be battery powered to take advantage of the latest technology and save space. This is a budgeted purchase in the General Fund, and these are available through NPP contract purchasing. The amount is greater than the estimated cost in the budget, but we have unused funds from other purchases, so no budget increase is required.

Fire Chief Joey Darby reported Under Resolution 25-1181, Council approved the use of opioid funding to purchase two Lucas devices for the Fire Department. Since receiving the (2) Lucas devices that were purchased, Stryker has realized that their quote was incorrect for the ProCare service agreement. The quote with the (2) devices only covered 1 device service agreement. The Fire Department requests permission to utilize the opioid funding to pay for the second ProCare service agreement that should have been included with the original purchase. The five year agreement amount is \$7,560.75, and would cover items such as parts, labor, travel, preventative maintenance, and batteries for the device. The current balance of the opioid account is \$215,478.04 as of 08/25/2025, which is enough to support these purchases. The capital purchase expense accounts must be amended even though the money is being paid out the opioid account.

Environmental Director Leslie Gahagan reported The Nature Parks Department requests permission to apply to ADECA's Recreational Trails Program Grant in order to build an elevated fully ADA accessible boardwalk with an observation deck at Wolf Creek Park. The boardwalk will be roughly 115ft linear feet and the observation platform will be roughly 12 feet above ground level. The grant is an 80/20 split. The total project cost is \$225,000 and if awarded, the grant will cover \$180,000 and the city would be responsible for \$45,000. The deadline to submit the grant is Wednesday, September 10, 2025.
