NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Reappoints R. Francine Hall to the YMCA Parks and Recreation Board beginning March 18, 2014 and ending March 18, 2020 based on the conditions that she submit a copy of the Alabama Ethics Law certification to the City Clerk to be included in the City's General Files.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.

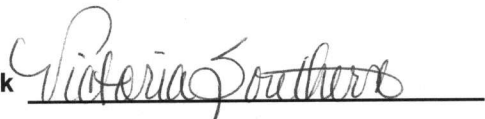

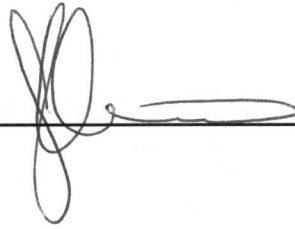

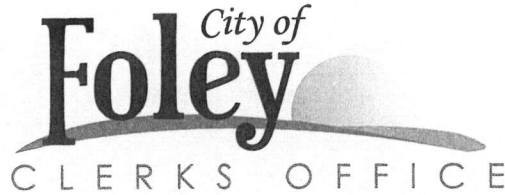
