He reported they received a quote from Goodwyn, Mills & Cawood for professional services to design the extension of Juniper St to SR59 at CR 20 and design a new traffic signal and the modification of the existing signal at CR20. They are requesting funds for consultant fees minus the CE&I portion and ROW deeds portion for a total of \$152,725. They will return to Council for construction and CE&I funding after bids are received.

City Administrator Mike Thompson reported this project is spread out over two years of the forecasted budget.

A Job Survey and Analysis has been completed on this position and it is recommended that the position be upgraded from an Administrative Assistant I (G-60) to an Administrative Assistant IV (G-100). The current FY20 Budget has a pool of funds available for position upgrades and this resolution authorizes a transfer of funds in the approximate amount of \$1,800 in support of this position upgrade with the action being budget neutral.
