DESCRIPTION OF MATERIALS OR PROPERTY

Title: Civil War Prints

Extent: Two Prints Nathan B. Forrest as subject

Scope/Content:

1. One print of Nathan Bedford Forrest on horseback by Don Stivers entitled "No Surrender" and subtitled "Nathan Bedford Forrest Escapes Ft. Donelson, Tennessee, February 16, 1862. The print is signed by the artist and numbered 1027/2500. The print measures 28"W X 32"H.
2. One print of Nathan Bedford Forrest leaning against a pine tree by David Wright entitled "Forrest: West Tennessee Campaign – December, 1862". The print is signed by the artist and is numbered 300/1000. The print measures 32"W X 29"H.

1. Subject to the terms and conditions hereinafter set forth, I, JERRY WILKEY
(hereinafter referred to as the Donor), hereby give, donate, and convey to the Foley Public Library, Foley, Alabama (hereinafter referred to as the Donee) the materials or property which are described above. Donor further represents and warrants to Donee that Donor is the sole owner of said materials or property, and is authorized and entitled to make all conveyance and representations contained herein.

2. Legal title to the materials or property shall pass to the Donee upon their delivery to the Donee. Donor reserves no rights or privileges, whatsoever, to the materials or property, but rather conveys all of the same to the Donee. Without limitation, Donor hereby gives and assigns to the Donee all rights of copyright which the Donor has in (a) the materials or property and (b) in such of the Donor's works as may be found among any collections of materials or property received by the Donee from others.

3. The Donor understands that the location, retention, cataloging, copying, reproduction, and preservation of the materials or property or other considerations relating to their use or disposition are at the sole discretion of the Foley Public Library in accordance with its policies. Materials or property shall be made available for research to all qualified persons.

4. In the event that the Donor may from time to time hereafter give, donate, and convey to the Donee other materials or property, title to such additional materials or property shall pass to the Donee upon their delivery, and all the provisions of this instrument of gift shall be applicable to such materials or property. A description of the additional materials or property so donated and delivered shall be prepared and attached hereto.

5. The responsibility of appraising materials or property remains with the Donor. The Donee is not authorized by law to provide appraisals for tax purposes.
