Discuss Council Meeting Agenda for June 17, 2013

The Council reviewed the Council meeting agenda for May 15, 2013 and had the following additions and removals:

Additions: There were two additions to the Council meeting agenda as follows: 13-0788: Consider resolution to waive or reduce building fees for Calvary Chapel Fellowship of Foley.

There was general consensus to waive the fees to minimum as is standard for this type of request.

Mayor's Comments

The Mayor commented he thought everyone did a great job on the Balloon Fest. There were a couple of "hiccups" regarding handicap parking, but those were worked out satisfactorily.

Staff/Visitor's Comments

Mr. Ron Rowe from Parish Lakes subdivision addressed the Council. He commented that the residents of Parish Lakes feel like orphans and not like part of the City. He added that they don't get any information about what is going on at the City. Rumor is that the Blue Collar development is going to be like a Branson or Six Flags and very near their community so many are concerned about that and some are getting quite angry. They are also worried about Pride Drive extension and if there will be enough buffer between their subdivision and that major roadway. They are also having problems with their pumps on the retention ponds and they cannot get any action from D. R. Horton who purchased it from Crossroads LLC. Mr. Rowe asked for help to oversee D.R. Horton because there are many problems with grass and weeds and rats. The Council assured Mr. Rowe that Pride Drive will have plenty of buffer and also that the Blue Collar is actually quite a long distance from their subdivision. The Council advised Mr. Rowe that the weed abatement process was very lengthy, but that the City will do everything within its power to help the residents. The Council also suggested that the residents form a Home Owner's Association to be able to address some of the issues. Parish Lakes is located in Councilwoman Vera Quaites district so she will follow up with the residents of Parish Lakes. The City is limited on what they can do on private property, but will do anything to help if possible.
