Downtown Mural & Street Art Project Guidelines and Application

Foley Main Street and the City of Foley seek to promote public art throughout the Main Street district with murals, street art, and Instagramable opportunities throughout the Foley Main Street district. Mural and Street Art projects are an investment in the culture of our community. They improve aesthetics, increase business and tourism traffic, and can help enhance the façade of a building or a specific area in downtown.

General Information

Foley Main Street in collaboration with local businesses and the City of Foley have pre-identified locations throughout the Main Street District for murals or original street art.

Murals and Street Art may be prioritized by Foley Main Street based on monetary contributions by property owners or private donors.

No mural or street art shall contain advertisement for any business or individual and may not contain any licensed, copyrighted, or trademarked characters or likenesses without permission from the holder or owner of the license, copyright or trademark.

Locations, size and themes of murals and street art will be determined by Foley Main Street working with local property owners. Murals cannot cover entire buildings. The size and the scope of the mural will be determined by Foley Main Street working with City officials and property owners to maintain the character of the property and adjacent properties. Street Art will be held to the same standards as above.

All projects on historic buildings must be approved by the City of Foley Historic Preservation Committee.

Subject matter and artwork will be approved by Foley Main Street in collaboration with other partners. All artwork will be all ages appropriate and family friendly.

Foley Main Street may work with an artist to finalize any design concept and may alter materials and colors if deemed necessary for historical purposes, durability and longevity.

All projects will be given a timeline for completion that is mutually agreed upon by all parties.

Artist Requirements

The following must be submitted by the artist or group of artists to be considered:

One to two conceptual sketches

A brief statement explaining the artwork and how it is relative to Foley Main Street

A resume with a photo of the artist(s) for media releases

A spec list of materials and paints to be used so to determine durability and the ability to withstand outdoor elements. Anti-graffiti clear coating must be installed.

Estimated cost of project including materials, artist time and talent.

Property owner agrees that the mural or street art will made accessible for the general public of all ability levels. Accessibility may require installing sidewalks or ADA compliant materials.

All parties agree to release and hold harmless the other in any case of liability related to the preparation or installation of the mural at the business address. This provision shall remain in effect beyond the expiration of the term.

Ordinance

Murals & Street Art in the Foley Main Street District

WHEREAS, the City of Foley desires to establish requirements for original murals and street art in the Foley Main Street District to promote the general welfare of community, improve aesthetics, increase business and tourism traffic, and help enhance the façade of a building or specific areas in downtown and;

WHEREAS, this ordinance is consistent with the intent of the Comprehensive Plan because the Comprehensive Plan goals generally include:

- 1. Creating a positive image through the use of attractive and well-designed artwork.
- 2. Creating attractive gathering spaces.

WHEREAS, the Foley City Council finds and determines that since murals and street art are considered to be original artwork they are not considered a "sign" and therefore, not governed under the sign ordinance.

WHEREAS, installation of original artwork murals and street art shall be limited to the Foley Main Street District;

WHEREAS, the City is mindful of the First Amendment to the Constitution, and does not want to judge the content of the mural or street art, including whether a mural or street art is commercial or noncommercial, so all words or letters are prohibited on murals and street art, and to classify murals and street art as art; and establish a permitting process.

SECTION ONE

Mural and Street Art permit application process

- (1) No person, firm, corporation or other entity may authorize, erect, construct, maintain, move, alter, change, place, suspend, or attach any Original Artwork Mural or Street Art within the City prior to obtaining a permit as set forth herein. Such permit shall be known as a mural permit.
- (2) An application for a mural or street art permit shall be filed jointly by Foley Main Street, a building owner and an artist with the planning department and accompanied by the Foley Main Street Mural and Street Art Contract and Release signed by all parties; and supporting documentation including a sketch of the proposed mural, artist resume, and a brief statement

describing the proposed artwork, and also a spec list of the material that will be used to construct the mural or street art.

FURTHERMORE

- 1. There shall be no cost to the city
- 2. Shall not interfere with public safety or create traffic safety issues
- 3. Shall be accessible to the general public regardless of disabilities
- 4. Shall be approved by the Foley Historic Commission when deemed necessary
- 5. A clear, anti-graffiti coating must be applied over the completed artwork
- 6. Shall not cover more than a single façade of a building
- 7. Shall not violate federal, state or local law
- 8. Shall not include any nudity, sex or innuendo, depictions of drugs and alcohol abuse, racism, degradation of individuals or groups, violence, desecration of cultural symbols, profanity or gang related art.
- 9. Shall not contain any licensed, copyrighted, or trademarked characters or likenesses without permission from the holder or owner of the license, copyright or trademark.
- 10. The mural or street art must be compatible with the character of the surrounding area in terms of its size, style, colors, materials, general appearance, and location.

This ordinance shall take effect immediately upon its adoption.
