Alec Barnett asked if he could serve hot dogs at the NAACP event in the Heritage Park on Saturday, October 22, 2016 from 10:00 a.m. until 3:00 p.m. There was a consensus from Council that it would be okay for hot dogs to be served as long as they were free of charge. If the organization planned to sell

the hot dogs, the organization may have to get a permit from the Health Department.

Floyd "Skip" Davis commended the Council on the growth of the City. He also reported that when the financial reports are verbally stated, it is hard for the general public to understand what the percentages are exactly and that it would be helpful to state the dollar amounts.

Mayor Koniar reported the City's Finance Department has again, received recognition for excellence in accounting. The Finance Department has received this award for three years in a row.

President Trawick reported the Publix Super Cup Soccer Tournament took place over the weekend. There were 93 teams and approximately 5,000 people at the tournaments that rotated in and out. He reported he received positive feed back from attendees about the fields. The fields drained properly but there were some drainage issue in the common areas that can easily be remedied. There will also be another soccer tournament during the first and second weekend in November that will host approximately 100 teams.

Council gave updates on construction of hotels. Alec Barnett asked if any of the new hotels will have meeting rooms. He reported the NAACP plans to hold their State Convention in this area and he would rather them come to Foley instead of Mobile.

Bill Swanson, who works at the Holmes Medical Museum reported there were approximately 40 people who went through the museum last weekend.
