



A BILL
TO BE ENTITLED
AN ACT

To alter, rearrange, and extend the boundary lines and corporate limits of the City of Foley in Baldwin County; and to provide for a referendum election on the approval of this act.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the City of Foley in Baldwin County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

TRACT 1

Section 2. In accordance with Section 11-42-6(b) of the
Code of Alabama 1975, a map showing what territory is proposed
to be annexed to the municipality of the City of Foley is on
file in the Office of the Judge of Probate in Baldwin County,
Alabama, and the map is open to the inspection of the public.

Section 3. Section 1 of this act shall become operative
only if approved by the qualified electors who reside within the
territory described in Section 1 who vote in a referendum
election to be held on the day designated by the Judge of
Probate of Baldwin County. The order setting the election shall
be entered by the judge of probate within 30 days of the
effective date of this act and the election shall be held not
less than 30 nor more than 50 days after the date of the order.



365 A reasonably convenient polling place for the election shall be
366 designated in the order by the judge of probate for the
367 referendum election. The polling place is not required to be
368 within the territory proposed to be annexed. The notice of the
369 election, including the designated polling place, shall be given
370 by the Judge of Probate of Baldwin County, and the election
371 shall be held, conducted, and the results canvassed by the judge
of probate. The notice shall be published in at least one
newspaper of general circulation in the City of Foley. The
question shall be, "Do you favor the adoption of Act _____, of
the 2023 Regular Session of the Alabama Legislature which
alters, rearranges, and extends the corporate limits of the City
of Foley in Baldwin County?

Yes () No ()." The City of Foley shall pay all costs and
expenses incidental to the election. If a majority of the votes
cast in the election are "Yes," Section 1 of this act shall
become operative immediately. If the majority of the votes are
"No," this act shall be repealed and shall have not further
effect.

Section 4. This act shall become effective immediately
following its passage and approval by the Governor, or its
otherwise becoming law.
