President Trawick reported there is a need for an Executive Session to discuss preliminary negotiations involving matters of trade or commerce in which the

City Administrator Mike Thompson reported the Executive Session will last approximately 30-45 minutes to discuss two items and Council will return for a vote on one of the items.

City Administrator Mike Thompson took the following roll call vote: Council Member Quaites, aye; Council Member Hellmich, aye; President Trawick, aye; Council Member Blackwell, aye and Council Member Ebert, III, aye. The vote was unanimous to go into Executive Session.

The Council meeting was recessed at 6:44 p.m.

Reconvened

President Trawick called the meeting to order at 7:24 p.m. All Council Members were present with the exception of Council Member Ralph Hellmich. Also present: City Administrator Mike Thompson, Vickey Southern, Katy Taylor Steve Smith and Jeff Rouzie.

A motion was made by Council Member Charles Ebert, III to abate the property taxes for BC Foley, LLC for a period of ten years once facilities are in service and excluding education taxes; to abate the sale taxes for BC Foley, LLC on materials used for the construction of the facilities and excluding education taxes. The tax abatements are contingent upon the adoption by the State of Alabama Revenue Department. The motion was seconded by Council Member Rick Blackwell and carried by an unanimous vote.

Mayor's Comments

No comments to report.

Visitor's Comments

Alec Barnett - 16694 Underwood Road addressed Council with his continued concerns over the conditions of Foley Housing Authority housing units. Mr. Barnett reported he spoke with Gloria Shanahan who is the HUD spokesperson in Washington D.C. and she stated that the removal of the Foley Housing Authority Director is the sole authority of the Mayor. Mr. Alec reported he obtained financial reports on the amount of money the Foley Housing Authority is receiving from HUD and he reported the money is not being used to repair and maintain the apartments. He report several residence have fallen ill because of the mold in the apartments. President Trawick reported he would like to see in writing that the Mayor has the authority to remove the director. Councilman Hellmich reported Council has never been told the Mayor has the

authority to remove anyone from the Foley Housing Authority. Council appoints the board members and the board members have the authority to hire and fire the Director. City Administrator Mike Thompson reported City staff will reach out to Ms. Shanahan and the City's attorneys to figure out how to rectify the current situation with the Foley Housing Authority.

Inell Harale - 622 East Gate Circle addressed Council with her concerns about the Beulah Heights park. She reported there are not enough playground equipment for the kids and the equipment that is currently there are old with sharp edges and the kids are getting hurt on them. Councilman Ebert, III reported some improvements have been made at the park within the past year. Ms. Harale reported only one piece of new equipment has been placed in the the park. She reported she will help raise funds to get new equipment. She also reported the police force the park to close before all other parks have to close. The park has to close at dark even when the churches are holding events at the park. Police Captain Bullock reported the church is gone by dark on their own wishes. Ms. Harale reported that was not true that the church was asked to leave the park at 8:00 p.m. Captain Bullock reported there are people who go to the park after dark to cause problems and the churches are gone by then and the intent is to keep the problems with fights, drugs and alcohol out of the park after dark. Councilwoman Quaites reported the church reports the times they will be in the park to the Police Department. It is normally from 10:00 a.m. until 8:00 p.m. and that is why the Police Department closes the park down at 8:00 p.m.

Captain David White reported he is not aware of the police closing the park before an event was over. The police have never told a church group holding an event at the park that they have to leave and close the park. The church is always gone by dark on their own accord.

Roddy Burkle - 8343 Bay View Drive addressed Council regarding Century Link. Mr. Burkle is a Century Link employee and he reported he would be happy to relay complaints the City is receiving to Century Link. President Trawick reported there is a list of people who can get service and City staff will get the list to Mr. Burkle.

Sharon Knight - 809 E. Azalea Avenue address Council with her concerns over the Beulah Heights park. She reported she has spoken with Home Depot and Lowes for assistance with building a better park for the Beulah Heights community. Councilwoman Quaites reported next year's budget for the Recreation Department may have Beulah Height playground equipment. The equipment must be budgeted and planned for. Mrs. Knight reported her intent was not to wait for the City, which is why she asked Home Depot and Lowes for assistance. Councilman Hellmich asked what exactly is Home Depot and Lowes purposing to do at Beulah Heights Park. Mrs. Knight reported they will help with Beautification and the help supply materials but they will need volunteers first. President Trawick reported Recreation Director David Thompson will be contacted as well to have him look at the existing equipment and see what needs to be done.

Shakira Pettibone- Foley Housing Authority resident reported she is a resident who has become ill due to the mold in her apartment and she can no longer live there. She asked Council how the residents can get proper representation on the Foley Housing Authority Board. City Clerk Vickey Southern reported she

will take resumes for any residents who are willing to serve on any of the City boards. Resumes can be submitted to the Clerk's Office with a list of the boards of interest. When a board appointment is due to expire, names and resumes are submitted to Council for their consideration.
