SECTION 3: That for all election held subsequent of the 2019 municipal election further authorizes the use of the same electronic vote counting machines and/or devices, that the Baldwin County Commission uses and approves the Baldwin County Municipalities to use which complies with Section 17-7-21 of the Code of Alabama and any regulations adopted pursuant thereto, is hereby authorized for the reporting, counting, and tabulating of any and all election results.

SECTION 4: That the Mayor of the City of Foley is hereby directed to file a copy of this resolution with the Secretary of State as provided in Section 17-7-21 of the Code of Alabama 1975.
