City Administrator Mike Thompson reported to Council about that the State of Alabama has entered into a settlement agreement with Endo Heath Solutions Inc. and Endo Pharmaceutical. Mr. Thompson reported that this settlement is in the amount of \$25,000,000. The mathematical formula of 60% stays in the state and 40% is distributed to local governments. Mr. Thompson explained to Council that the net that will be issued to the City is approximately \$33,000. This formula would be different if the pharmaceutical company is going through the bankruptcy process. Mr. Thompson stated that the process of distribution of the settlement doesn't go by population but by federal or CDC numbers that show opioid deaths or the number of people that are struggling with opioid abuse within local governmental areas. He also reported that there are 10 -12 pharmaceutical companies that are going through settlements or bankruptcy and this could continue to build into a material dollar amount. Mayor Hellmich reported that he recommends looking into local other municipalities and to explore different avenues of utilization. Mr. Thompson reported that if municipalities didn't participate in this settlement that they would have to seek their own legal counsel and file a separate law suit. There was no further discussion on this item.
