North and South Apron - Pavement Maintenance (ALDOT-75/25)

The sponsor intends to seek State and Local funding for Fiscal Year 2025 for the above referenced project. The project description and cost estimate are based on visual inspection of existing conditions or expected conditions for future projects. A detailed investigation should be performed during the design phase.

Project Description

The project will involve pavement maintenance for the existing North and South Aprons. Work will include the application of an asphalt seal coat and the installation of new pavement markings. Typical preservation efforts, such as seal coats, help extend pavement life by maintaining its structural integrity.

A pavement condition inspection conducted as part of ALDOT's 2019 system-wide update assigned the South Apron a Pavement Condition Index (PCI) of 86. The North Apron was rehabilitated in 2020 with a nominal 2-inch mill and fill overlay. At this time, both aprons are eligible for pavement preservation.

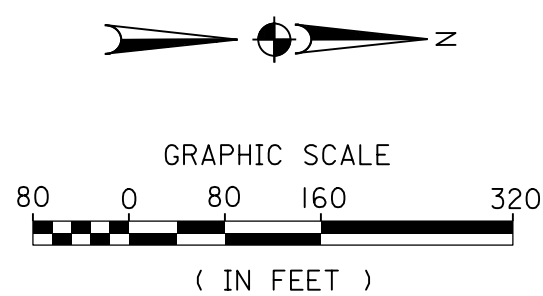
