City Administrator Mike Thompson reported that the City collected the most sales tax revenue in history during the month of June 2013. The lodging tax showed a 6.3% increase and the rental tax showed a 7% increase. The months of June showed revenue increases due to tournaments and the August's monthly report will show July numbers.

Fire Chief Joey Darby gave a synopsis of the July 2013 report. He reported July was in line with other months and the Department had been busy with four structure fires. One structure fire was on Garner Road; it started in the bedroom and displaced the family. There was a fire in a utility building caused by the improper storage of a lawn mower. The storage building was a total loss. There was a fire at a house in Magnolia Springs that was confined to the garage area and a balcony fire at Alison Pointe Apartments. There were no injuries in any of the fires and no displacements occurred in the last three fires. There was a potential carbon monoxide incident caused by a golf cart when the battery got hot and expelled carbon monoxide in a garage.

Chief Darby also reported that the new custom pumper truck should arrive next month to replace the existing vehicle. The production is one to two weeks ahead of schedule.

Councilman Hellmich asked Chief Darby if the security upgrades have been completed. Chief Darby answered in the affirmative and the only area available to the public or unauthorized personnel is the reception area.

Police Chief David Wilson gave a synopsis of the July 2013 report. He noted that there had been a lot of wrecks this past month that the officers had to work. Also noted was 54 inmates attended Alcoholics Anonymous and 145 inmates received drug counseling. He reported these are mandatory classes but hope that the inmates take it to heart so that they can better their lives.

Chief Wilson reported that there will be interviews this week for the Corporal position. There will be an oral board of examiners made up of seven officers from other cities that will interview the candidates. Chief Wilson also reported today is the first day of school and the new School Resource Officers have been busy. The new patrol cars have been very popular with the media and the schools as the signage says "School Resource Officer. Police and schools working together".

Councilman Ebert asked about the new additions to the Police Department family. Chief Wilson reported two babies were born and all are doing well.

Visitor's Comments

Mr. Pankaj Patel of American Best Hotel in Foley expressed his displeasure of the increased lodging tax that was adopted under enabling Ordinance 13-1036 on July 15, 2013, and further objected to the Council suspending the rules for the immediate adoption of Ordinance 13-1038 that was adopted on August 5, 2013. He felt that the Council should have met or advised the hotel managers prior to the increase to gain their input. President Trawick reported Council went through the normal process of adopting the original ordinance and the suspension of the rules to pass the amendment (the second ordinance) was done because the original ordinance had an effective date that started immediately at publication of the ordinance and the amendment was to amend the effective date to October 1, 2013. He further reported the managers were to be advised of this action.

Mr. Patel further stated the CVB held quarterly meetings to keep the business owners informed. After Cathy left there were no more meetings held. He felt that they would lose business because he felt the increase was excessive. It was noted that the Lodging Tax was increased to bring the City of Foley's lodging tax in line with the surrounding cities.

Adjourn

A motion was made by Councilman Hellmich to adjourn the meeting. The motion was seconded by Councilman Blackwell and the vote passed unanimously. The meeting adjourned at 6:16 P.M.
