- 6 sites have not been repaired as of 9/25/2014.
- Of these 6, consultants are developing plans for 3 (Pecan St. Culvert, FBE Wingwall Failure, and Justice Center Flume).
- Engineering will be developing plans for the remaining 3 (Airport Outfall Ditch, Michigan Ave. pavement repair, and Sonny Callahan Bridge riprap replacement.
