#### I. Hydraulic Spreader

The department has selected the Holmatro® Spreader model SP 5240 with CORE Technology™ Couplers "Brand Name or Equal" as being the hydraulic spreader brand and model that best represents their needs for use in being compatible with the existing hydraulic rescue tools the department possesses. Quantity shall be (1) or more.

#### II. Hydraulic Cutter

The department has selected the Holmatro® Cutter model CU 5050i with CORE Technology™ Couplers "Brand Name or Equal" as being the hydraulic cutter brand and model that best represents their needs for use in being compatible with the existing hydraulic rescue tools the department possesses. 


