Dream Center Presentation: Pastor Joe Aldrete

Pastor Joe Aldrete Executive Director of the Dream Center reported to Council that this outreach program has supported forty youth of Baldwin County and as of now, twelve are enrolled. Pastor Aldrete reported that the Dream Center is a 501(c) (3) non profit organization and was established in June of 2021. Pastor Aldrete reported to Council that this organization relies on community support for many needs. This program provides a juvenile court diversion to assist high risk and troubled youth of Baldwin County and also assists with food, clothing, mentoring, and basic life skills.

Pastor Aldrete reported to Council that because of the delay of disbursement of the DYS grant money and it was advised to reapply before February of 2023, in one year they raised \$15,000.00. Pastor Aldrete is asking the City of Foley to partner with the Dream Center. He reported that they provide life skill services for children in the Foley area and through out Baldwin County. City Administrator Mike Thompson asked Pastor Aldrete how much would the Dream Center need and if other agencies and municipalities are participating because that amount could grow to \$15,000. Pastor Aldrete reported that he will be going to other municipalities and agencies.

Council Member Richard Dayton asked Pastor Aldrete if any of the Foley Churches have taken an interest in this program? Pastor Aldrete reported that his church is greatly invested and fully supportive of the Dream Center. Pastor Aldrete reported that he will look further into the local churches.

Council Member Charles Ebert, III, reported that he supports this program. Council Member Rick Blackwell asked Pastor Aldrete if the Dream Center is in the positive and Pastor Aldrete responded that for now, it is.
