Originally from St. Paul Minnesota, I've lived in Foley since March 2013.

From 1985 to 2013, I lived in San Diego, where I obtained a Bachelor of Arts in Communication from San Diego State University, followed by a career with various County of San Diego departments.

I supervised the crime prevention unit in North West San Diego County for the Sheriff's Department. worked for a time at the Air Pollution Control District as a public information officer, then was recruited by the Department of Public Works.

Within three weeks of being hired at Public Works as a public information officer, the department undertook a major reengineering process. Since then, I've played an integral role in the department's ongoing administration. Because the department was rapidly changing department management moved me fluidly into a succession of positions and continued to add responsibilities, eventually making me Deputy Director in charge of Management Services Division. The succession of titles doesn't directly relate to the progression I've made in responsibility and leadership, which was continual. As you can see from my resume, I have deep knowledge of internal government systems and operation of landfills, airports, roads, land-use, sewer systems, flood control, assessment districts, environmental permitting and more.

I also have a sister who lives in Foley who's had homes here since the mid 1980's so I have visited and loved this area for many years.
