This is NOT budgeted, but the Engineering Department has completed two projects which were budgeted and completed below budgeted amount.

Juniper St sidewalks est was \$60,000 completed for \$41,373.40 with \$18,626.60 remaining.

Monteith Oaks inlet repairs est was \$13,750 completed for \$5,595 with \$8,155 remaining.

Inlet Project Requested \$47,823 - \$26,781.60 (under budget projects balance) = **\$21,041.40** needed for this project.

***We have \$25,691 remaining in our Maintenance - Streets/Drainage/Signals/Lights account that could also be used.

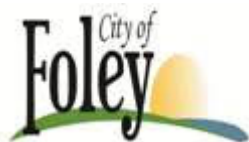
