10 AN ACT  
11

12 To alter, rearrange, and extend the boundary lines  
13 and corporate limits of the City of Foley in Baldwin County.  
14 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

15 Section 1. The boundary lines and corporate limits  
16 of the City of Foley in Baldwin County are altered,  
17 rearranged, and extended to include within the corporate  
18 limits of the municipality, in addition to the lands now  
19 included, all of the following territory:
