Thank you for selecting Thompson Engineering, Inc. (TEI) to perform Construction Engineering and Inspection (CE&I) services for the City of Foley (City) on the subject project! This proposal contains our understanding of the project, proposed scope and fee, and our Agreement to provide services.

BACKGROUND AND UNDERSTANDING

Our understanding of the project is the City is ready to construct the proposed intersection improvements on Foley Beach Express at CR-12. We understand that the plans consist of two separate projects, with one project being funded in part by a federal grant program and the other project being funded entirely by the City.

The federally-funded project is being administered by the Alabama Department of Transportation (ALDOT) through a funding agreement with the City acting as a Local Public Agency (LPA). TEI is an ALDOT pre-qualified on-call CE&I consultant and is prepared to meet the requirements of this project.

The level of effort required by the federally-funded project is different from the City funded project and TEI is prepared to meet the requirements of each, while maintaining an appropriate level of effort on each.

The proposed items of work include:

- Secure a geotechnical sub-consultant to perform construction materials testing services
