Kevin Carnley reported to the Council that it is time to retire K9 Saban and purchase a new canine for the handler. City Engineer Chad Christian reported to the Council that he has reviewed the plans. Mr. Christian reported that due to this agreement involving three different organizations, all parties must be in agreement. There was no further discussion on this item, it remained on the agenda.

Rachel Keith reported to the Council that the pre-application will be completed in FY 19 and the work will be completed during FY 20. There was no further discussion on this item, it remained on the agenda.

18 0562 A Resolution Authorizing the Snook Family YMCA to Use a Portion of Performance Contract Funds For Facility Repairs

City Administrator Mike Thompson reported to the Council that the YMCA would like to use a portion of the annual contract funds to repair the flooring and the pool at the YMCA facility. There was no further discussion on this item, it remained on the agenda.

18 0570 A Resolution to Set a Public Hearing to Consider Entering Into A Sponsorship Agreement With the South Baldwin Chamber of Commerce for

their Gateway Initiative

City Administrator Mike Thompson reported to the Council that due to the nature of the funds being used a Public Hearing is necessary. There was no further discussion on this item, it remained on the agenda.

18 0572 A Resolution Authorizing the Mayor to Execute The First Amendment to the "Foley Beach Express" Agreement

There was no discussion on this item, it remained on the agenda.

18 0573 A Resolution of the City of Foley, Alabama, in Support of Hurricane Michael Victims Along the Florida Panhandle

Sue Steigerwald reported to the Council that she has found extra funds in her budget to allow for the donation of funds to Hurricane Michael victims, she suggested that each department take a look at their budget and see if they are able to find extra funds to add to the Finance Department's overage. Deputy Chief Chad Brewer reported to the Council that that the Fire Department is working with first responder of Bay County Florida to donate directly to those first responders needing assistance. There was a consensus to allow each City Department to review their budgets for extra funds to donate to hurricane victims in an amount up to \$2,500. There was no further discussion on this item, it remained on the agenda.

18 0574 A Resolution in Support of State Funding Assistance for The Baldwin County Intracoastal Waterway (ICW) Boat Launch Project

City Administrator Mike Thompson reported to the Council that this resolution is similar to a previous resolution but it is more specific for the use of Gomesa funds. There was no further discussion on this item, it remained on the agenda.

Mayor's Comments

There were no comments to report due to the Mayor's absence.

Visitor's Comments

Kim Hillman of the Snook Family YMCA reported to the Council the YMCA's annual report. Ms. Hillman reported to the Council that the Foley YMCA has the best support of any of the YMCA's that she covers. Ms. Hillman reported to the Council that the Snook Family YMCA has the second largest membership, in 2018 there was an average of 13,700 scans into the YMCA each month, and that no citizen has been turned away due to inability to pay. There was no further discussion on this item.
