SECTION 1: Council would like to thank Representative Holk for her support of Graham Creek Nature Preserve and their Haunted Forest event.

SECTION 2: Memorializes the application submitted on behalf of the City of Foley and accepts the FY2024 Legislative Event Grant for \$2,600.

SECTION 3: Approves to amend the budget as follows: 100-5090-6051 (Printing & Advertising Expense) by \$1,300 and 100-5090-6160 (Event Operations Expense) by \$1,300 and 100-5090-4300 (GCNP - Event Grants Revenue) by \$2,600.

SECTION 4: Council authorizes the Mayor and other City officials to execute the grant agreement and other documents as required for the acceptance of the grant.

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
