WHEREAS, the State of Alabama Ethics Commission says that public officials/board members fall under the State Ethics Law, and therefore should have the opportunity to educate themselves regarding the law, and

WHEREAS, the Alabama Ethics Commission has recently developed an online video training of the Alabama Ethics Law, which can be accessed at their website at [www.ethics.alabama.gov](http://www.ethics.alabama.gov), and

WHEREAS, all newly appointed and reappointed board members must submit a copy of their training certification to the City of Foley as a condition to being appointed/reappointed to the boards.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: The term of membership of the Library Advisory Committee as first appointed, appoints Jessica Gosa for the term of one (1) year beginning on July 1, 2024 and ending on July 1, 2025; Brett Taylor for the term of two (2) years beginning on July 1, 2024 and ending on July 1, 2026; Beverly Wenzel for the term of three (3) years beginning on July 1, 2024 and ending on July 1, 2027; Rachael Gebhart for the term of four (4) years beginning on July 1, 2024 and ending on July 1, 2028; and Rick Blackwell for so long as he remains on the City Council of the City of Foley.

SECTION 2: Upon conclusion of the first terms, respectively, all appointments to the Library Advisory Committee shall be for terms of four (4) years.

SECTION 3: All appointments are based on the condition that they submit a copy of the Alabama Ethics Law certification to the City Clerk to be included in the City's General Files.

SECTION 4: This Resolution shall become effective immediately upon its adoption as required by law.
