A Resolution Approving Professional Services for the Downtown Residential Streetscape Conceptual Design.

The City of Foley is launching a project to revitalize the streetscape of our historic downtown neighborhoods. This initiative will focus on enhancing six key streets covering four city blocks: Alston Street from Jessamine south to Verbena (100' right of way), West Jessamine Avenue (100' right of way), West Orange Avenue (100' right of way), West Myrtle Avenue (100' right of way), and West Verbena Avenue (80' right of way), along with South Chicago Street from West Laurel Avenue to Myrtle Street. There are three areas planned for FY24 (W Jessamine, W Rose, and W Orange), and one area planned for FY25 (W Myrtle). Christian Preus Landscape Architecture, PLLC had provided an estimate for \$55,415.00 for the conceptual design of the downtown neighborhood as described above.

WHEREAS, Christian Preus Landscape Architecture, PLLC had provided a proposal for the conceptual design on enhancing six key street: S Alston from Jessamine south to Verbena (100' right of way), W Jessamine (100' right of way), W Orange (100' right of way), W Myrtle (100' right of way), and W Verbena (80' right of way), along with S Chicago from W Laurel to Myrtle.
