NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Accepts of the award from the Alabama Department of Economic and Community Affairs (ADECA) division for the South Baldwin Regional Workforce Development Authority in the amount of \$500,000.

SECTION 2 Approves to amend the budget accordingly: \$500,000 as grant revenue, under account #100-6010-4200 ADECA S Baldwin Workforce Authority Grant and \$500,000 as grant expense, under account 100-6010-6025 ADECA S Baldwin Workforce Authority Expense.

SECTION 3: Authorizes the Mayor, Clerk, and other City officials to sign the grant agreements, sub-recipient agreements, contracts and other documentation as required.

SECTION 4: This Resolution shall become effective immediately upon its adoption as required by law.
