NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Declares the Mel Roberts Park bathroom/concessions building, asset numbers 3006, 3056, 3057, 5496, and 9921, as surplus and approves the demolition and disposal of the structure.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.
