SECTION 1: Approves the Mayor and City Staff to negotiate the purchase of certain real property located east of Hickory Street and north of US HWY 98 in an amount not to exceed \$350,000 under Account No. 400-1010-5106 Land Purchase-West US98 .

SECTION 2: Authorizes the Mayor to sign all appropriate documents for the purchase.
