The Nature Parks Department has expressed the need for a zero turn mower to replace an existing one that is not repairable. Mowers are in limited quantity with price increases after October 31. The Nature Parks Department requests to purchase a Ex-Mark 52" 4 Series Deck zero turn mower under Account 100-5090-5100 for \$8924.00 from G & J's Power Equipment, Inc. In the FY22 budget for capital purchases, Nature Parks included a utility trailer for \$8000. Also there is \$924 that can be transferred from Printing/Advertising Budget in the Operating Accounts.
