NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Declare the structure on the property located at John B. Foley Park as surplus and authorizes the removal of this structure by demolition and/or best means possible.

SECTION 2: Allocate \$2000 to Account No. 400-5060-5103 for all fees including Landfill fees and demolition.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.
