A Resolution to Increase the Environmental Budget and Approve the Capital Purchase of a Mosquito Sprayer

The Environmental Department requests the increase in the Environmental Capital Purchases budget for the emergency purchase of a Guardian mosquito sprayer in the amount of \$8200.. The sprayer was in the proposed 2021 budget, but due to equipment breakage there is an immediate need to avoid disruption in city mosquito control. The lowest quote was from Adapco for\$8200. Other companies equipment would require the purchase of new software and hardware bringing their quotes to a much high amount than the Adapco product.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approves the increase in the Environmental Capital Purchases Account No. 100-2040-5100 by \$8200, and approves the purchase of the Guardian Mosquito Sprayer from Adapco for \$8200.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.
