WHEREAS, Hellmich Electric Inc submitted a quote for the electrical work to include: three lights and poles (LED lights), two poles with no lights, conduit run from the panel in alleyway, and photocell to run the light fixture.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approve the Professional Services Proposal from WAS Design for the landscape architectural services in the amount of \$3,000.00

SECTION 2: Approve Cooper Fence Company as the lowest responsible quote in the amount of \$8,221.45.00

SECTION 3: Approve Hellmich Electric Inc's quote in the amount of \$27,000.00

SECTION 4: Appropriate \$33,000.00 to Account #400-5060-5104

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
