On August 15, 2022 the City of Foley entered into an agreement by resolution 22-1272 with the Alabama Department of Corrections for the utilization of inmate labor in a work release type setting. WHEREAS, the Alabama Department of Corrections has provided a 12 month renewal for the utilization of inmate labor, and

WHEREAS, Public Works is asking Council to authorize the Mayor to renew the agreement with the Alabama Department of Corrections

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Authorizes the Mayor to re-enter the agreement with the Alabama Department of Corrections for the utilization of inmate labor.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.
