A Resolution Approving the Surplus & Disposal of 8 Ball Field Light Poles and Fixtures at Mel Roberts Park.

Parks & Recreation requests to have 8 ball field light poles and their fixtures at Mel Roberts Park declared surplus and disposed of by the best means possible. They are about to be replaced with a new lighting system and these old and outdated lights and poles are no longer needed. The items are:
