system will capture the radio traffic digitally, and

WHEREAS, Quality Recording Solutions, LLC has provided a quote for the upgraded replacement NexLog Eventide system, utilizing GSA Contract # GS-35F-0415V, for the amount of \$21,703.75

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approves the purchase of the NexLog Eventide recorder system under GSA Contract # GS-35F-0415V from Quality Recording Solutions, LLC for a total of \$21,703.75 under account # 1000-1040-5100.
