WHEREAS, the City of Foley plans to make certain improvements at the Foley Municipal Airport; and,
WHEREAS, the Federal Aviation Administration (FAA) has certain funding and financial assistance

programs that can help finance improvements at the Foley Municipal Airport.

WHEREAS, the planned improvement is the construction of a new terminal building at the airport.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: That the City of Foley is hereby authorized to make application to the FAA for airport improvement funding assistance for the purpose of undertaking an terminal building project in FY25.

SECTION 2: That either the Mayor or the Airport Manager of the City of Foley are hereby each authorized, directed, and empowered to apply for and to enter into an airport improvement funding agreement with the FAA, including all understandings and assurances contained therein, and to each act in connection with the application and agreement and to provide such additional information as may be requested.

SECTION 3: That the authority of the City of Foley to enter into contracts with the FAA has been reviewed by the City of Foley attorney, and in his opinion, the City of Foley is duly authorized to commit the City of Foley to an agreement with the FAA.

SECTION 4: That the City of Foley hereby affirms that the local matching share of the money required to complete the project will be officially approved, placed in the budget, and available for expenditure upon execution of the FAA funding agreement that includes the project budget, prior to the commencement of this project.

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
