A Resolution Approving the Highway 59 Sidewalk Project from East Verbena Avenue to Centennial Bank and accepting The Capstone Engineering Group's Professional Services proposal for the Survey and Design.

Street Department planned \$1M in FY24 for Sidewalk Improvements throughout the City and requests to approve Highway 59 Sidewalk Project from East Verbena Avenue to Centennial Bank to be the first project of FY24. Engineering received professional services agreement for the Highway 59 Sidewalk Project from East Verbena Avenue to Centennial Bank project from The Capstone Engineering Group in the amount of \$24,600 for survey and design. This project will provide needed connectivity for downtown Foley. Street Department will return to council at a future time to request permission to solicit bids and construction funding.
