A Resolution Authorizing the Magnolia River Stream Cleanout Project

The Magnolia River has been identified as a stream in need of being cleaned out due to flooding caused by debris. GreenCo has provided a quote to perform this debris removal for \$397,650.00. The County will take responsibility on cleaning out the portion of the river that falls in their jurisdiction, and we are requesting to remove the debris in the portion that falls in Foley's city limits.
