A Resolution Approving the Renewal of the Agreement with the Alabama Department of Corrections, Loxley C. W. C, for Inmate Labor

On August 15, 2022 the City of Foley entered into an agreement by resolution 22-1272 with the Alabama Department of Corrections for the utilization of inmate labor in a work release type setting. The term of the agreement is 12 months. Public Works is asking the Council to authorize the Mayor to re-enter into the agreement with the Alabama Department of Corrections.
