NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Amends Resolution 18-1111-RES to state the buy-back purchase price of the Lot 5 of the Wilson Pecan property in the amount of \$498,000 under Account No. 400-1010-5100 Wilson Pecan Property Lot 5 Buy Back and amends the account accordingly.
