Requests Permission to Apply for the Alabama Historical Commission 2019 Historic Sites Grant.

The Historic Depot Museum requests the permission of council to apply for the Alabama Historical Commission 2019 Historic Sites Grant in order to help offset expenses to replace the depot museum roof in FY 2019. The grant applications are due on August 15, 2018 and the grant will be awarded by October 31, 2018. The maximum awarded grant is \$20,000 with no match required. The roof repair will take place in FY 2019 with all remaining expenses being paid for out of Capital Projects Fund. A proposal has been received that estimates the roof replacement to cost approximately \$20,000.
