NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approves the creation of two new funds (Fund 206 & 207) within the city for the Sports Tourism Department.

SECTION 2: Approves that all activity from 10/1/2017 moving forward will be moved to those funds including transferring the FY18 budget.

SECTION 3: Approves the creation of a new Bryant Bank account for said funds and the following signers on the bank account: Wayne Trawick, Ralph Hellmich, Charles Ebert III, and Sue Steigerwald.

SECTION 4: Appropriates \$306,008 to 206-1012-4810 transfer from general fund and 100-8000-8007 transfer to FST Event Center Operations to fund the operating cost.

SECTION 5: Appropriates \$298,598 to 207-1012-4810 transfer from general fund and 100-8000-8010 transfer to FST Multi-Use Fields Operations to fund the operating cost.

SECTION 6: This Resolution shall become effective immediately upon its adoption as required by law.
