NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Accepts the total costs in the amount of \$53.54 for the abatement of weeds at Lot 149 Meadow Run ., Tax Parcel ID #05-61-02-09-0-001-004.055 and authorizes the City Clerk to forward a copy of the costs to the Baldwin County Tax Collector to be collected under the "Optional Method of Taxation" pursuant to *Sections 11-51-40 through 11-51-74 Code of Alabama, 1975*; whereupon it shall be the duty of said tax collector to add the amounts of the respective weed lien to the next regular bill for taxes levied against the respective parcel of land.
