WHEREAS, Gulf Shores Title is requesting an amendment to change the name from Azalea Fund to Alston Laurel NE, LLC in order to conform to the Owner's Policy Proposed Insured/Buyer name, and WHEREAS, therefore, Section 1. of Resolution 18-1149 must be amended to state Alston Laurel NE, LLC.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Amends Section 1. of Resolution 18-1149 to state Alston Laurel NE, LLC instead of Azalea Fund.
