WHEREAS, the City of Gulf Shores, Alabama, has requested the approval for the construction of a median crossover and intersection improvements at the intersection of County Road 8 and the Foley Beach Express, and

WHEREAS, the City of Foley, Alabama, Baldwin County Commission and Baldwin County Bridge Company, LLC believe it to be in the best interest of the parties and for the orderly movement of traffic in the area to authorize and approve the construction of the proposed median crossover and intersection improvements, subject to the terms and conditions set forth in the First Amendment to the Foley Beach Express Agreement, and

WHEREAS, the parties desire to amend the "Foley Beach Express" Agreement and any and all exhibits, maps, documents and agreements related thereto in order to allow for the construction of the proposed median crossover and intersection improvements.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows: SECTION 1: Approves the construction of the proposed median crossover and intersection improvements located at the intersection of County Road 8 and the Foley Beach Express.

SECTION 2: Authorizes the Mayor to execute the First Amendment to the "Foley Beach Express" Agreement.

SECTION 3: This Resolution shall become effective immediately upon its adoption as required by law.
