SECTION 1: Grants permission to the Depot Museum to memorialize the application for the FY2019 Alabama Bicentennial Grant.

SECTION 2: Accepts the \$2,500 grant awarded from the Alabama Bicentennial Commission Foundation for the development of a collections policy.

SECTION 3: Amends the budget by \$2,500 in both 100-5060-4300 (AL Bicentennial Grant Revenue) & 100-5060-6020 (Consultant & Professional Fees)
