NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approves fireworks display to be held at the OWA grounds at 8:45 p.m. on May 25, 2019.

SECTION 2: Approves fireworks display to be held at the OWA grounds at 8:45 p.m. on July 4, 2019.

SECTION 3: Approves fireworks display to be held at the OWA grounds at 8:45 p.m. on August 31, 2019.

SECTION 4: This Resolution shall become effective immediately upon its adoption as required by law.
