SECTION 1: Accepts this donation and amends the FY19 budget to reflect an increase of \$2,893.82 in the Fire Department Donations account 100-2020-4651 and an increase of \$2,893.82 in the Public Education account 100-2020-6052, for a net effect of \$0.

SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.
