WHEREAS, Foley Police Department requests to purchase a Community Service Smoker/Grill Trailer for \$5,604.00 from HBT Smokers LLC to be used at various community events, and

WHERAS, there is \$6,000 budgeted in the FY20 budget in account 100-2010-5100, but a Walmart grant was expected to cover 80% of the cost of this purchase, however the Walmart grant was received in previous fiscal year and used to purchase jumbo sized games and speakers to be used at community events.
