WHEREAS, The Council adopted Resolution #20-1116 on May 4, 2020 implementing spending reduction measures of which included gaining permission of Council for the filling of vacant positions. This resolution authorizes the filling of three recent vacancies; 1) Sanitation Worker III/Driver Operator vacated due to retirement; 2) Sanitation Worker II vacated due to promotion; and 3) Human Resources Specialist vacated due to promotion. All of the action in this resolution is budget neutral.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Authorizes the filling of a vacancy created by retirement in the Sanitation Department for the budgeted position of Sanitation Worker III/Driver Operator.

SECTION 2: Authorizes the filling of a vacancy created by promotion in the Sanitation Department for the budgeted position of Sanitation Worker II.

SECTION 3: Authorizes the filling of a vacancy created by promotion in the General Government/HR Division for the budgeted position of Human Resources Specialist.

SECTION 4: All action in this resolution is budget neutral.

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
